Official Information request and response

Thank you for your request under the Official Information Act ("OIA") dated 21 February 2025.

You have requested:

- 1. Information for all platform funding decisions in 2023/24 and 2024/25 for funded radio platforms
- 2. The criteria for assessing all platform funding applications in 2023/24 and 2024/25
- 3. A list of all funding decisions related to audio, podcasts, music, and features with video content that are or could be broadcast over radio in 2023/24 and 2024/25.

Please see our response below:

- 1. Please find attached the funding recommendation papers submitted to our Staff Investment Committee or the Board for approved operational funding for radio platforms in 2023/24 and 2024/25. We have redacted names and personal information under section 9(2)(a) of the OIA to protect the privacy of natural persons. We have also redacted audience data and financial information under section 9(2)(b)(ii) on grounds that releasing the information would likely unreasonably prejudice the commercial position of the entity who supplied the information.

- 2. To clarify, NZ On Air provides annual operational funding to specially targeted platforms to create and deliver public media content of particular cultural or social value. This funding is administered through a closed round, which for access, student and Pacific radio, is limited to these platforms as their outputs promote New Zealand music and allow NZ On Air to specifically deliver audience outcomes for women, youth, children, persons with disabilities and ethnic minorities as required under section 36 of the Broadcasting Act 1989.
